2. **MINUTES**

The Minutes of the Annual General Meeting of the Council held on the 19th May 2015, were approved as a correct record, and signed by the Chairman.

3. **TO SUBMIT CORRESPONDENCE.**

In response to the Council's invitation for a representative of Deeco to attend a meeting, we have received an email from Mr Gareth Edwards advising he was unable to attend this meeting, but would be happy to answer any specific questions by letter of email. It was agreed we should invite him to attend the July meeting of the Council.

We were advised by email from PSCO Susan Holmes that the police would not be able to attend this meeting due to rest days and annual leave.

Letter from Flintshire County Council in connection with a Matched Funding Scheme for Improvements to Children's Play Areas for 2015/16.

Email from the Welsh Assembly in connection with the Public Health (Wales) Bill - Provision of toilets available for use by the public. This Bill will place a duty on the local authority to prepare and publish a local toilets strategy on the provision of toilets available for public use. The Bill will now be considered by the National Assembly in the coming months.

There had been a meeting at County Hall on the 16th June when this had been confirmed. There would now be a period of consultation and review until November 2015, when a final decision would be made.

There was a general discussion concerning this item and all Councillors present expressed their opposition to the closure.

There have been several meetings locally in connection with proposed Fracking in the Dee Estuary. A company, Cluff, have been licensed to proceed with Coal Gasification tests in the area.

To invite a representative of Cluff, Mr Gary Nancarrow, to attend our next meeting to explain the proposals and procedures to be carried out.

It was reported that a skip business is being ran from a residential property at Woodlands, Llanasa Road, Gronant. This is causing parking and environmental problems in the village, which should be addressed.
