I hope everyone is keeping safe and well as we continue with the lockdown restrictions due to the Coronavirus. Thankfully, the number of cases appears to be reducing and there may be some relaxations of the restrictions later this week when the Welsh Government carry out their next review.

At present, the National Association of Local Councils have not changed their advice that physical meetings should be postponed until further notice. With this in mind, I have attended Clerks' video meetings with the local branch of SLCC via 'zoom'. While there were some initial concerns regarding security, these now appear to have been resolved. I am happy to schedule a trial 'zoom' meeting for anyone who would like to join in. I am aware that other Town & Community Councils, and indeed the County Council, have successfully held meetings via this application. I will schedule the meeting for 7.00pm on Tuesday, 23rd June and will send out joining instructions by email earlier that day. I hope to see as many of you as possible. You will of course, need to download the 'zoom' application onto whichever device you propose to use.

The following events and matters affecting Council since May:

- **Street-lighting Upgrade:** MEGA Electrical have still not resumed operations but have confirmed our upgrade will be prioritised once they return.
- **Internal audit for the year ended 31st March 2020:** The audit has been completed by JDH Business Services, and I enclose copies of their report for the year for your consideration. I would point out that the bank balance referred to in item 1 does balance. (£5018.01 plus £805.00 = £5823.01) I enclose a copy of the bank reconciliation for your attention. The Annual Return has been amended to reflect items 2 and 3 accordingly.
- **Defibrillator Equipment:** I am pleased to confirm that donations have been received from various local businesses including Councillor Glyn Banks, to fund the purchase of a further set of defibrillator equipment. This is being situated at Lobitos Garage on the A548 Coast Road, and is scheduled to be installed this week.
- **Welsh Government Burial Grant:** I have received confirmation from Flintshire County Council that we will receive a grant amounting to £2838.70 in respect of funding for the burial of 1 child U18. We have been asked to 'ring-fence' this funding to be spent on Cemetery Improvement Projects where possible.
