Councillors

I hope everyone is keeping safe and well, thankfully, the number of cases appears to be reducing and many businesses are now returning to some degree of normality.

At present, the National Association of Local Councils have still not changed their advice that physical meetings should be postponed until further notice. I propose to schedule another 'zoom' online video meeting for 7.00pm on Tuesday, 21st July and will send out joining instructions by email earlier that day. I hope to see as many of you as possible. Hopefully, following the August recess, we will be able to resume physical meetings, with some social distancing measures in place, on the 15th September. I will send out the usual paperwork shortly before that date. I have spoken to the Head-teacher at Ysgol Bryn Garth who has indicated there may be some problems with the use of the Community Centre, but perhaps we could meet at one of the other centres around the area if Bryn Garth is unavailable? I will keep everyone advised of the situation.

The following events and matters affecting Council since June:

- **Street-lighting Upgrade:** MEGA Electrical have now resumed operations and work has recommenced on the upgrade of our street-lighting. The work on installing cut-out switches has, I understand, been started, and hopefully the works will be completed as a matter of urgency.
- **Defibrillator Equipment:** I am pleased to confirm that following donations from various local businesses including Councillor Glyn Banks, a further set of defibrillator equipment has been installed, situated at Lobitos Garage on the A548 Coast Road. An additional set of equipment has been ordered and will be installed in the village of Llanasa within the next 7 - 10 days.
- **Welsh Government Burial Grant:** The grant amounting to £2838.70 in respect of funding for the burial of 1 child U18 has been received. We have been asked to 'ring-fence' this funding to be spent on Cemetery Improvement Projects where possible.
- **External Audit for the year ended 31st March 2020.** The paperwork is being collated to send off to the external auditors within the next 14 days, although I have been advised that we should not expect the report back until September at the earliest.
- **Children's Summer Play-scheme.** Flintshire County Council have confirmed that they are planning to run the Summer Play-schemes at the three locations we have previously indicated - Penyffordd, Gronant and Trelogan. These will be reduced to two-week schemes running ten sessions, commencing on the 17th August 2020. I will forward further information on the scheme as I receive it.

- The community of Trelogan have been busy refurbishing the duck-pond at the lower end of the village, which has been reported in the local newspaper. A request has been made for Llanasa Community Council to consider adopting the pond. I understand this would only involve the item being included on the Community Council insurance documents as the Trelogan community have indicated they will carry out any maintenance required.
- The notice-board in the village of Trelogan has been blown down by the recent storms, and Councillor Mike Williams has indicated it is beyond repair. Would the Community Council be prepared to fund the purchase of a replacement?
