I hope everyone is keeping safe and well, and managing to get some normality back. It has certainly been a strange year so far, not what we all hoped for on 1st January!

It would appear that the National Association of Local Councils have now changed their advice that physical meetings may recommence, with social distancing measures in place, in light of the easing of the lockdown restrictions. I am expecting our September meeting to take place on its scheduled date, 15th, although I will be meeting with the Head-teacher at Ysgol Bryn Garth in early September and will confirm arrangements after that.

The following events and matters affecting Council since June:

- Street-lighting Upgrade: MEGA Electrical have indicated the street-lighting upgrade work
  has recommenced and are planning for completion by the end of August. Salix Finance are
  also expecting completion by the end of the month in order that the balance of the funding
  can be released.
- **Defibrillator Equipment**: I am pleased to confirm that a further set of defibrillator equipment has been installed in the village of Llanasa, situated at the Village Hall opposite the church.

  August 2020. I have been advised by Janet Roberts of Flintshire County Council that there

  costs of lunches provided for children attending the Play-scheme at all three locations.
